In 2016, Taiwan had a Gross Domestic Product (GDP) of US \$529 billion. In 2015, Taiwan was ranked as the United States' 9th-largest trading partner in goods, placing it ahead of markets such as India and Brazil.

It was also the 14th-largest U.S. export market overall and the seventh-largest export market for agricultural and livestock products, valued at US\$3.28 billion. The level of economic growth coincides with changing consumption patterns across Taiwan.
